_____ I shall carry a copy of the Order of Appointment and a photo driver's license and shall, upon request or inquiry of any person, show these at the time service is made or attempted.

_____ My failure to follow the Ohio Civil Rules or Trumbull County Domestic Relations / Juvenile Local Rules shall result in revocation of appointment and subject me to the penalties of contempt of court.

_____ My appointment to serve process may be revoked at any time at the sole discretion of the Judge making the appointment or the Administrative Judge.
